Public Hearing – Conditional Use Request by Premier Real Estate Management, LLC for Development of Multi-Family Residences

Moved by Trustee Smith, seconded by Trustee Berken to enter in the Public Hearing.

No comments were made by the public. J. Moes stated that the Plan Commission had reviewed the conditional use request and they recommended on a 4 to 1 vote that the Village Board approve the conditional use request. J. Moes explained that the development consists of five (5) two story buildings and each building will have twelve (12) apartment units with attached garages. J. Moes stated that the project meets all zoning requirements and a conditional use is required because the parcel is zoned commercial highway district. Trustee Frassetto questioned the reason for the one dissenting vote by the Plan Commission and President Vanden Berg stated he believes the Commissioner voted against the conditional use because he didn't seem to favor building more apartments.

Moved by Trustee Frassetto, seconded by Trustee Smith to exit the Public Hearing.
