Village Engineer, Chris Murawski presented on the 2017 Harvest Trail paving project which includes curb and gutter. There will be no sidewalks at this time but aprons will be installed. He explained the grading limits and that some are low and some are high and the lower grades will have to go into the property to match. Matching will also be done in the right-of-way with inlet with storm sewers installed. There will be a 6 a foot parking lane on the north side with two driving lanes 10 feet wide. An overview was presented regarding the hours of construction, affected utilities, parking, emergency services, mailboxes and mail delivery, garbage and recycling pickup and financing options. Homeowners were then able to ask questions specifically directly regarding their property that were answered by the Public Works staff.

Presentation—Fox River Boardwalk Feasibility Study Report and Findings

Pat Skalecki with GRAEF presented on the Fox River Boardwalk Feasibility Study. The purpose of the boardwalk is to provide pedestrians and bicyclists friendly connections between Little Chute and Kaukauna by providing public access to the river and natural areas with abundant wildlife, fishing and kayaking. The boardwalk will be located near Heesaker Park spanning from the Village of Little Chute to the City of Kaukauna over the Fox River. Pat Skalecki with GRAEF and Bob Jakel, the Director of Planning and Community Development for City of Kaukauna have been working on this collaboration since September 2016. An initial stakeholder meeting was held on October 11, 2016 and public informational meetings were held on October 25, 2016, October 29, 2016, November 29, 2016 and January 24, 2017. Four initial bridge railing types, 7 lighting styles and 4 decking types were discussed. The project's estimated cost range is 2.4 million for Steel Girder Style to 2.7 million for Truss style.

RESOLUTION NO. 9, SERIES OF 2017

A Final Special Assessment/Hookup Fee Resolution authorizing special assessments/hookup fees for installation and construction of municipal improvements as described hereinafter, within an area described hereinafter, and providing for the levying of special assessments or hookup fees. As applicable, against said property owners as described hereinafter under and pursuant to the provisions of Sections 61.36, and as applicable 66.0701, 66.0703, and 66.0907, of the Wisconsin Statutes, and Sec. 16-87 of the Village Code of Ordinances as amended from time to time, and further pursuant to applicable village ordinances.

WHEREAS, the Village Board of Trustees, Village of Little Chute, located in Outagamie County, Wisconsin, did create Sec. 16-87 of the Village Code of Ordinances entitled "Hookup Fees for Improvements Benefiting Properties Located Outside of the Village to be Imposed Upon Annexation and for Assessments Proceedings for Completed Municipal Improvements", thereby declaring the Village's intent to exercise special assessment and police powers under Wisconsin statutes in particular, Sections 61.34, 61.36, and as applicable 66.0701, 66.0703, and 66.0907 of the Wisconsin Statutes, and as applicable Sec. 16-87 of the Village Code of Ordinances as amended from time to time, and as further amended by then applicable Village Ordinances, for the following purposes and within the following described area:

Grand Avenue from McKinley Avenue to the North—concrete paving, new storm sewer, private storm sewer laterals, private sanitary laterals, rehab sidewalk/new sidewalk

McKinley Avenue from Madison Street to Jackson Street—concrete paving, new storm sewer, private storm sewer laterals, private sanitary laterals, rehab sidewalk/new sidewalk

Wilson Street from McKinley Avenue to the North—concrete paving, new storm sewer, private storm sewer laterals, private sanitary laterals, rehab sidewalk/new sidewalk

Legion Parkway from McKinley Avenue to Madison Street—concrete paving, new storm sewer, private storm sewer laterals, private sanitary laterals, rehab sidewalk/new sidewalk

Rehab Sidewalk generally bounded by Buchanan Street to East Village Limit and from CTH "OO" to South Village Limit

WHEREAS, the Village Board of Trustees did provide for the publishing of the required statutory Notice of Public Hearing on Special Assessment/Hookup Fee in the *Times/Villager* on February 20, 2016 and did further mail a copy of said Notice of Public Hearing on Special on Special Assessment/Hookup Fee to all affected property owners as set forth within the above-described project area, all within the required statutory time, including a scale map (if available) of the project area: and,

WHEREAS, the specially benefited property affected and property owners therein affected by the municipal improvement project are as set forth above: and,

WHEREAS, the Village Board of Trustees, Village of Little Chute, did hold a Public Hearing upon said Special Assessment/Hookup Fees, on the 2nd day of March, 2016, at 6:00 p.m. in the Board Room, 108 W. Main Street, Little Chute, WI 54140, pursuant to the published Notice of Public Hearing and a mailing of said Notice to affected property owners, for the purpose of informing and hearing all interested persons concerned with the Special Assessment/Hookup Fee and the Report of the Village Engineers reference the proposed public improvement project, and did hear all persons desiring audience at said hearing (or in the alternative the Report of the Village of Little Chute Director of Public Works in lieu of Village Engineer Report).

NOW THEREFORE, BE IT RESOLVED by the Village Board of Trustees, Village of Little Chute, as follows:

1. That the Report of the Village Engineers for the public improvement project, affecting the special assessment and hookup fee area, all as described above, including any and all engineering plans and specifications thereto, are hereby approved and adopted. Pursuant to the Report of the Village Engineer and/or the Village Director of Public works as set forth above, or in the alternative to the foregoing provisions pursuant to Sections 16-87(e) of Village Ordinances for fully or partially completed work. All of said special assessments/hookup fees proposed are determined to have been levied and proposed on a reasonable basis, being actual construction costs, engineering fees, attorneys' fees, publications costs, Village administrative costs and fees and other special assessment proceeding and hookup fee proceeding costs; and, further, that all said municipal improvements are determined to specially benefit the areas/properties being assessed, or charge with hookup fees, as applicable.

2. That the Village of Little Chute awarded a contract to carry out the work of said improvements in accordance with the Report of the Village Engineer/Village Director of Public Works, or in the alternative work was completed and performed by others for which the Village contributed payments for such public improvements.

3. That payment for said municipal improvements shall be made by assessing the cost to the abutting/affected property owners located within the Village jurisdiction pursuant to Sections 61.34 and/or 61.36, and pursuant to authority and police powers and as applicable 66.0701, 66.0703, and 66.097 of the Wisconsin Statutes, and as applicable Sec. 16-87 of the Village Code of Ordinances as amended from time to time, and as set forth hereinafter and further pursuant to any applicable Village Ordinance or Policy dealing with special assessments, and further made in part by imposing hookup fees at the time and manner set forth below for those properties presently located outside Village jurisdiction.

4. The Village of Little Chute had advertised for bids for this project and the Village of Little Chute did award a contract to carry out the work for said improvements, all to forementioned, and/or in the alternative work was completed and performed by others for which the Village contributed payments for such public improvements.

5. That all costs to be assessed or later charged as hookup fees, as shown on attached Engineer's Report and/or the Report of the Village Director of Public Works, as modified, are true and correct, have been determined on a reasonable basis, are further determined to specially benefit the abutting/affected property, and are hereby confirmed.

6. Special Assessments on parcels located inside the Village will be paid as detailed in the Final Engineer's Report for those properties under Village jurisdiction. Final rates are identified in attachment to this Resolution.

7. Hookup Fees and/or special assessments will be charged to those parcels that are included in the project area (as detailed in the Final Engineer's Report) but are not currently located in the Village and will be imposed and held in abeyance until the time of annexation to the Village all pursuant to Sec. 16-87 of the Village Code of Ordinances, none of which constitute a current lien against properties located outside of the Village limits until time of annexation, and no interest will be charged for the period prior to annexation. Such hookup fees and special assessments are hereby deferred in accordance with Sec. 16-87 of the Village Code of Ordinances.

8. The Village Clerk for the Village of Little Chute is directed to publish this Resolution as a Class One Notice in the *Times/Villager* Kaukauna, Wisconsin.

9. The Village Clerk for the Village of Little Chute is further directed to mail a copy of the Final Assessment Resolution and a statement of final assessment against affected/abutting property, to each affected/abutting property owner whose name appears on the assessment roll and whose post office address is known or can, with reasonable diligence, be ascertained.

10. This assessment and hookup fee amount may be amended and/or revised, where necessary, from time to time, pursuant to Sections 66.0701, 66.0703 (10) of the Wisconsin Statutes, Village ordinances or policies associated therewith, as amended from time to time.

11. Effect of Village Ordinance(s). See Village of Little Chute Municipal Code Chapter 16, Article III. The assessment and hookup fee rates have been modified and/or adjusted to reflect the Village of Little Chute local share, as paid by Village of Little Chute General Funds where applicable.





EXPLANATION: On Wednesday, March 15, at the Regular Board meeting GRAEF Engineering and the Parks Department presented our report on the Feasibility and Cost Analysis Study performed on the Fox River Boardwalk project. The Village of Little Chute, City of Kaukauna, and GRAEF began the study in September of 2016 and ended in March of 2017. During those 6 months, there was extensive public and agency involvement with the design, location, and even the general concept of the project. The response from the public was extremely positive both locally and regionally in regards to the boardwalk.

Currently, the boardwalk is scheduled in the Village's Capital Improvement Plan for 2019. With this as our target year, our current schedule is listed below.

- 2016/2017 – Feasibility and Cost Analysis Study – **COMPLETED**
- 2017 – Geotechnical Investigation, Soil Sampling, Environment Assessment, Schematic Design, Fundraising Assistance, and Agency Coordination.
- 2018 – Structural Design, Civil Design, Permitting, and Grant Writing/Fundraising
- 2019 – Bidding/Construction

The next phase of this project would be for the Village and City to perform geotechnical investigation, sampling of soils, an environment assessment, schematic designs, initial fundraising assistance, meetings with permitting agencies, and more contact with the Canadian National Railroad. This phase of the project will cost \$97,960. The breakdown is located below.

- Village of Little Chute - \$40,230
- City of Kaukauna - \$40,230
- Outagamie County Greenways 2017 Grant - \$17,500

In order to proceed with the next, phase the department recommends that the Village chooses an alignment. This will save on the cost of borings substantially. The recommended alignment from the parks department is alignment 1. After speaking with users, going out on the river, utilizing public meetings and working with the angle of the crossing I feel this alignment is the most economical while still taking into consideration the needs of the local residents. If the Village moved forward with alignment 1 in the next phase of the project there would still be an opportunity to alter the alignment before structural design, civil design, and permitting.

Fox River Boardwalk

Funding Opportunities

GRAEF's economic development specialists have investigated multiple funding opportunities for the planned project. The below summary outlines programs and other approaches that we feel are best suited for this project or where it would be eligible for funding based on the early project scope.

Knowles-Nelson Stewardship Grant Program

This is one of the major funding sources for trail and pedestrian bridge projects in Wisconsin. Applications are due May 1st of each year (annual grant competition). This project would apply under the category of "Acquisition and Development of Local Parks". This program can fund up to a maximum of 50% of eligible project costs. Grant money is disbursed on a reimbursement basis after project implementation.

Assessment: The City of Kaukauna and Village of Little Chute are limited to the number of Stewardship grant applications that can be submitted. If both communities agree that this project is the highest and best use of their prospects for Stewardship grant funding, it appears to have a high likelihood of funding.

Federal Recreational Trails Act Program

This is a federal grant program for trail projects that is administered in conjunction with the Knowles-Nelson Stewardship Grant Program. Applications are due May 1st of each year (annual grant competition). Applications are identical to Knowles-Nelson Stewardship Grant applications. \$45,000 maximum grant per year. This program invokes federal requirements (i.e. Davis/Bacon wage compliance, National Environmental Policy Act, etc.)

Assessment: The City of Kaukauna and Village of Little Chute are limited to the number of Federal Recreational Trail grant applications that can be submitted. If both communities agree that this project is the highest and best use of their prospects for Federal Recreational Trail grant funding, it appears to have a high likelihood of funding.

Fox River/Green Bay Natural Resource Damage Assessment (NRDA)

This is a funding source generated from the settlement of the lawsuit regarding PCB contamination of the Fox River. The Fox River/Green Bay Natural Resource Trustee Council accepts restoration project proposals that restore, rehabilitate, and /or acquire the equivalent of the natural resources that have been injured by the release of PCB's. There are three specify funding areas that the program is targeting: #1 – Aquatic, Nearshore, and Riparian Habitat Improvements; #2 – Fishery Resource Enhancement; and #3 – Public Use Enhancement. Applications can be submitted at any time (currently no grant deadline), and there is no set limit on the amount of funding for a given project.

Assessment: Right now this funding source has a substantial amount of money that will be made available for grant projects (\$3 million annually for the next five years). The boardwalk project is located within the "restoration area" established for grant funding. This project represents a unique

opportunity to provide additional access to the Fox River and should compete favorably for grant funding.

DOT Transportation Alternatives Program

This is a transportation related program targeting non-motorized modes of transportation. Recreational only trails are not eligible. A project would need to document transportation value in order to be eligible to apply. Projects need to follow WisDOT/FHWA process. Project timeline is important and must comply with WisDOT funding timeline requirements. This program can fund up to 80% of project costs. It is also administered on a reimbursement basis. The next grant application deadline will likely be January, 2018.

Assessment: In order for this project to be eligible to apply, Kaukauna and Little Chute would need to include this boardwalk as part of their bicycle transportation system. The grant application would first compete in the Fox Cities Metropolitan Planning Area competition, and if not successful could also then compete in the statewide Transportation Alternatives Program grant competition.

DOT FAST Program

This is another transportation related program administered by the Wisconsin Department of Transportation that will provide \$100 million of grant money for projects in Wisconsin. In order to be eligible to apply the project must be part of the "National Highway System" or "National Scenic Area". The deadline for applications was April 16, 2016. It is assumed that this grant program will continue with an annual competition each spring.

Assessment: Given that this boardwalk project is neither part of the National Highway System or National Scenic Area, it is not eligible to apply. Unless a creative strategy is developed to link the boardwalk project to an eligible activity, this grant opportunity is likely not viable.

Federal Maritime Heritage Grants

This federal program provides grants for maritime education and preservation projects. In 2016 they provided \$1.7 million nationally. The program requires a 1:1 match with non-Federal money. Education related projects can apply for a maximum of \$50,000, and preservation project can apply for up to \$200,000.

Assessment: Unless a strong argument can be developed for education and/or maritime preservation, it will be difficult to compete effectively for this pool of grant funding.

Outagamie County ATC Fund

In February of 2017, the Outagamie County board unanimously approved setting aside \$1.5 million from money dedicated towards park land development. The board approved utilizing this money for projects that are taking place in Outagamie County that reflect their comprehensive plan of creating trails along the Fox River from Neenah-Menasha to Wrightstown. The Village's project is directly included in their map and plan.

Outagamie County Greenway Fund

Designed as a partnership grant opportunity for local units of government to further develop Outagamie County's greenway system, up to 25% of a greenway project's costs can be reimbursed as part of this program. For 2016, \$25,000 in funding has been allocated for greenway projects.

Assessment: This is a fairly small local funding opportunity, but it represents another source of match funding for the project.

PeopleForBikes Community Grant Program

PeopleForBikes is a small grass-roots organization focused on promoting bicycle transportation. They have solicited a small amount of donations from sponsor organizations to make available for bike related grants. According to their web page they have provided over \$3 million in grant awards to 356 project in 50 states.

Assessment: This is very small grant program that provides grants averaging \$8,427 (\$3mm/356 projects). Kaukauna and Little Chute will need to decide whether the potential for a grant award outweighs the cost of pursuing and administering the grant project.

Other Private Donations & Sponsorships

Many communities have partnered with the private business community and local individuals to participate in a project through direct donations and sponsorships. This effort would require a champion from the communities to actively meet with and secure donations from private businesses or individuals. The champion would need to develop an outreach program for generating public enthusiasm and awareness via media sources. Tools to garner public support would be of value such as attractive imagery and photo-realistic renderings of the proposed bridge. Ideas would need to be developed to incorporate recognition of sponsors and major donations into the project. Based on the success of other local communities, funding through this avenue can be substantial.

State or Federal Earmark

In addition to competition in traditional grant programs, Kaukauna and Little Chute have the option to pursue funding directly from lawmakers at the state or federal level. While the process requires lobbying and is otherwise generally undefined, communities in Wisconsin have been successful in securing money through both of these avenues.

EXPLANATION: At the March 1, 2017, Regular Board meeting Megan Kerkoff, of 516 Taylor Street requested the ability to tap municipal terrace trees for sap. The recommendation from the Forestry Department is that we continue to not allow the practice of tapping municipal owned terrace trees. The reasoning for this decision is located below.

- 1. Opening a wound in a tree** – Every time you open a wound in a tree it opens up an opportunity for rot and decay. Rot and decay can lead to the tree rotting and becoming a safety hazard. A rotting tree can lead to it falling during a wind storm and harming an individual or damaging vehicles parked in a drive way or on the road.
- 2. Terrace Trees already have a higher risk** – Terrace trees are already at a disadvantage compared to a tree in someone's backyard or in a park. There is limited area for root growth due to sidewalks and the road. Many terraces also have poor soil conditions. The soil in a terrace typically isn't as rich in nutrients as the soil in a park setting.
- 3. Harmful Chemicals** – Due to being next to the road terrace trees may contain salt, oil, and other road chemicals in their sap.
- 4. Ordinance 40-152(a2 & a5)** - It is currently against ordinance to tap terrace trees.
 - Break, injure, mutilate, deface, kill or destroy any tree or shrub or permit any fire to burn where it will injure any tree or shrub.
 - Attach any sign, poster, notice or other object on any tree, or fasten any guy wire, cable, rope, nails, screws or other device to any tree; except that the village may tie temporary "no parking" signs to trees when necessary in conjunction with street improvement work, tree maintenance work or parades.

Options Going Forward

My recommendation is that the Forestry Department investigates ways to facilitate a program or an avenue in which residents can partake in the tapping of maple trees during the maple syrup season. Options could include but are not limited to the following.

1. Creating a program for 2018 at a designated area such as Heesakker Park to teach a limited number of interested residents on how to tap maple trees.
2. Partnering with another public or private entity that already has classes or opportunities to tap maple trees on their property.
