# 2026 Budget Highlights

2025 Net New Construction is \$15,396,200 or a .967% increase resulting in additional levy capacity of \$46,499

Total levy limit capacity is \$4.6072 Assessed and \$4.5611 Equalized or \$179,118 increase in the levy. There is no allowance for the Consumer Price Index in this program. The 2025 Budget is ~\$1K under this restraint.

We no longer qualify for the Expenditure Restraint Program as our tax rate has dropped below 5 mills.

2026 Budget proposed rates \$4.6063 Assessed (31.88% decrease or \$2.1561) and \$4.5602 Equalized (9.14% decrease or \$.4588) due to market valuation that creates ~ 1.0 aggregate ratio.

# 2026 Budget Highlights

- The 2026 Budget includes a 2.5% COLA for non-represented employees with potential (varies by employee based on position in pay grade) for a step increase based on performance evaluation. FVMPD contract will be expiring December 31, 2025.
- WRS increased from 6.95% to 7.20% in 2026 for General Employees while Protective with Social Security experienced a decrease of .21% resulting in an employer rate of 14.80% (15.01% in 2025).
- Utility Fees – The Sewer Utility planned second increase of 4% was approved by the Village Board while a Water Rate Study will start in fall 2025 continuing into 2026 for submission to the Public Service Commission.

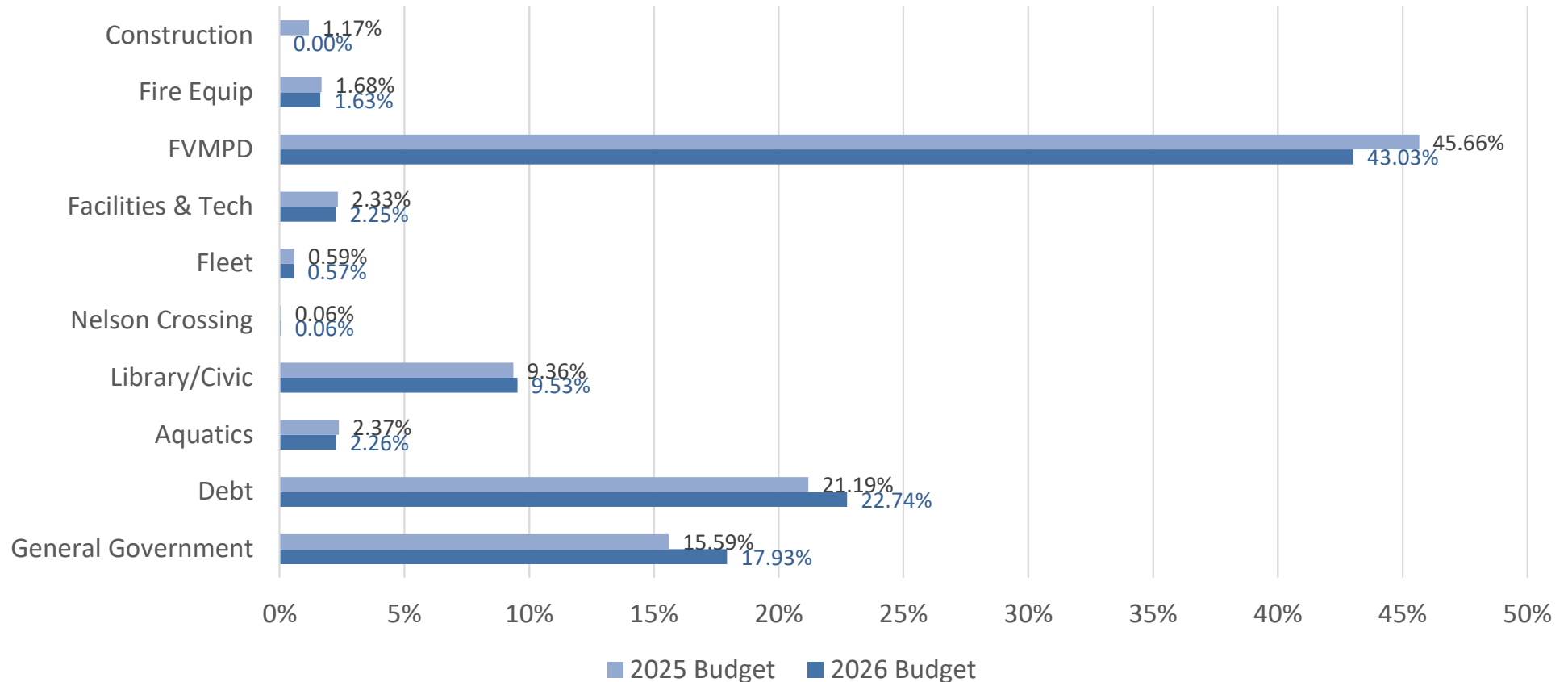

# 2026 Budget Items to Note

- Village wide salary and benefits have decreased 3.16% or \$268K despite health insurance employer cost increase of 3% due to staffing changes: reduction of four police officers (offset by \$396K added for contractual services due to staff turnover), not funding the Police Captain and Deputy Clerk positions and addition of a .75 Assistant Village Administrator position
- Administrative Services – increase for four elections versus two in 2025 (\$14K)
- DPW – identify up to five crosswalks for possible Rectangular Rapid Flashing Beacon (RRFB) installation; selection two for design and installation (\$90K) in 2026 and plan for others in future
- DPRF – addition to Parks building maintenance for fascia board replacement and to pressure wash/mildew remover then stain seal applicable shelters (\$11K)
- Economic Development – Business retention incentive Smith Pharmacy (\$100K) when complete
- Promotional Fund – Market on Main (\$10K), Match for Village Fireworks (\$5K)
- Heesakker Trust – Continued collaboration for community amenities to add to the \$154K staircase project (\$2.737MM)
- Fleet – Skid Steer (\$120K) Pickup Truck (\$49K)
- Construction Fund – Miami Circle (\$1.1MM); Arthur Street (\$357K) Buchanan Overpass Lighting and Sidewalk (\$86K); Intersection Improvements Holland Road and County Highway OO (\$50K) and CTH OO and N (\$25K)
